

CONTRACT AGREEMENT

This AGREEMENT made this _____ day of 30 APR 2024 between the **DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE XI** located at Ramon Magsaysay Avenue Corner Suazo Street, Davao City, Philippines (hereinafter called "the Procuring Entity") of the one part and **DCTECH MICRO SERVICES, INC.** located at DCTECH Bldg., Shanghai St., Matina Aplaya, Davao City Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Procuring Entity invited Bids for the **Provision of 9-Month Internet Subscription as Primary Internet Services for the DSWD Field Office XI, Regional Office, and Sub-Regional Sites** and accepted a Bid by the Supplier for the supply of those goods/services in the sum of **Two Million Seven Hundred Fifty Thousand Two Hundred Fifty Pesos Only (Php 2,750,250.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of Two Million Seven Hundred Fifty Thousand Two Hundred Fifty Pesos Only (Php 2,750,250.00), the Supplier agrees to the Provision of 9-Month Internet Subscription as Primary Internet Services for the DSWD Field Office XI, Regional Office, and Sub-Regional Sites in accordance with its Bid.

4. The *Procuring Entity* agrees to pay the above mentioned sum in accordance with the terms of the Bidding.
